By signing below, I hereby waive any claims for, and release FCC-NW and its officers, directors, employees, members and agents from, all liability to me and my family members, personal representatives, assigns, heirs and next of kin for any loss, damage or any claims or demands for damage made on account of injury to me or my property or resulting in my death, however caused, while I am participating in the Heritage Camp.
